<b>Required Attachments</b>	The completed, signed application must be accompanied by a three-generation pedigree:  Attach an 8.5" by 11" photocopy of a three-generation pedigree issued by an acceptable domestic or foreign registry. For a list of acceptable registries, see the <i>Special Registry Services</i> pamphlet available on our website: <a href="http://www.akc.org/rules/special_registry_services.cfm">www.akc.org/rules/special_registry_services.cfm</a> . <b>Do not send the original pedigree.</b>
