	 A copy of the Stud Certificate issued by the registry organization in whose Stud Book the Sire is registered, or a 								
	official letter from that registry organization, must verify, with its official Club Seal and authorized signature, that the person signing as owner of the Sire was, in fact, the recorded owner of the dog at the time of the mating an that the foreign Sire was mated to the bitch named on the Foundation Stock Service® Special Litter Registration Application form.								
	The individual AKC FSS® recording of the Dam, imported in whelp, must be effected before consideration will be given to an application for litter recording.								
	If a Sire has sired seven (7) or more litters in his lifetime or more than three (3) litters in the calendar year, an AKC DNA profile must be on file. The DNA kit may be ordered from our Web site: www.akc.org.								
	If a Dam was leased at the time of mating or birth of a litter, you must submit an Foundation Stock Service® Lease Notification form.								
	If there are more than two (2) dam owners, contact the AKC for an Additional Signature form.
