- Incomplete applications and/or applications received without the required fee(s) will not be approved.
- Test Secretary or Chairperson cannot judge at this event.
- Applications MUST be received at least **90 days** (3 months) prior to the start date. Late applications are subject to a minimum \$50.00 penalty.
- ONCE A TEST HAS BEEN APPROVED, NO REFUNDS WILL BE ISSUED.
- Premium lists are required for standalone tests, a copy of which must be sent to AKC at the time it is sent to prospective entrants.
- Coursing Ability Tests/FAST CAT® held in conjunction with a Lure Coursing Test or Trial may use the same premium list, however a separate event application form, event secretary's report and results form must be submitted.
