<b>Litters Mated and Born in US</b>	Submit a Litter Registration Application form <i>instead</i> of this form.	
<b>Multiple-Sired Litters</b>	Request a Multiple-Sire Litter Registration Application and use a Multiple-Sire Litter Registration Application form to register each litter. The application cover page contains details on fees and required DNA certification.	
<b>Artificial Insemination Litters</b>	<b>Fresh Semen:</b> Submit an Application to Register a Litter Resulting from Artificial Insemination Using Fresh Semen. <b>Fresh Extended Semen:</b> Submit an Application to Register a Litter Resulting from Artificial Insemination Using Fresh Extended Semen. <b>Frozen Semen:</b> Submit an Application to Register a Litter Resulting from Artificial Insemination Using Frozen Semen.	
<b>Fees</b>	Processing fees are nonrefundable and all fees are subject to change without notice. A litter application fee always comprises two parts: a processing fee (\$30.00) plus a puppy fee (multiply the number of puppies by \$2.00).  Additional fees are determined by circumstance: <div><div>Expedited Handling (\$35.00)</div><div>Expedited Handling is available in the Continental U.S. only. <b>Additional Requirements</b>	Additional Requirements: <ul style="list-style-type: none"><li>• A legible copy of the official three-generation pedigree for the Sire issued by the Foreign Registry in the Sire's country of birth. Do not send original.</li><li>• A copy of the Stud Certificate issued by the registry organization in whose Stud Book the Sire is registered, or an official letter from that registry organization, must verify, with its official Club Seal and authorized signature, that the person signing as owner of the Sire was, in fact, the recorded owner of the dog at the time of the mating and that the foreign Sire was mated to the bitch named on the Special Litter Registration Application form.  The individual AKC registration of the Dam, imported in whelp, must be effected before consideration will be given to an application for litter registration.</li><li>• If a Dam was leased at the time of mating or birth of a litter, you must submit an AKC Lease Notification form.</li><li>• If there are more than two (2) dam owners, contact the AKC for an Additional Signature form.</li><li>• Import DNA requirement: All imported dogs (male or female) registered on or after March 1, 2006 require AKC DNA profiling prior to the registration of their first AKC-registered litter.</li></ul>	
<b>Authorizations</b>	Signatures of persons other than the owners or lessees will be accepted only if a properly completed authorization form has been filed with the AKC.
