We receive frequent requests from AKC Therapy Dog title holders for AKC to recognize that Canine Good Citizen test items are included in the therapy dog assessment administered by a therapy organization.

Effective July 2015, dogs who are 1) registered with an AKC recognized therapy organization and 2) have earned an AKC Therapy Dog title may receive the official Canine Good Citizen® title when the owner submits the attached application.

Because the recognized therapy organizations already test all of the CGC items on their therapy tests, the dog does not have to take the Canine Good Citizen test.

Your dog must have earned an AKC Therapy Dog title (THDN, THD, THDA, THDX or THDD) or you must be enclosing an AKC Therapy Dog title application along with this CGC title request.

Owners can apply to have CGC added to the dog's title record by submitting this application along with a \$12.00 fee.
