To earn the AKC Trick Dog title, you and your dog must meet the following criteria:

1. Must be Registered or Listed by having either a AKC, Purebred Alternative Listing (PAL) or AKC Canine Partners (CP) number. All dogs, including purebreds and mixed breeds can get a number. Having a number allows AKC to issue titles under a specific dog record.
2. Complete the Tricks listed for the level in the presence of an Approved CGC Evaluator, or as another option, submit proof (copy of certificate or Title) of the level achieved with *Do More With Your Dog!*TM

To apply for an AKC Trick Dog title, complete this application and send to the address above with a \$20 processing fee. Applications can also be emailed or faxed. If your application is not approved due to not meeting the qualifications, you will be notified and your fee will be refunded.

AKC Trick Dog Title Application Checklist Make Sure You've Included Everything:

- Complete all sections of this application.
- TRICKS CHECKLIST** either **1)** signed by an AKC Approved CGC Evaluator. With the application, include only the TRICKS CHECKLIST for the title for which you are applying (Novice, etc.) **OR 2)** proof of title (copy of DMWYD certificate) you have achieved at the the same level with *Do More With Your Dog!*TM (For example, for AKC Intermediate Tricks title, send *DMWYD* Intermediate proof.)
- AKC Number or [AKC Canine Partners form](#) to get a number only if you don't have an AKC, [PAL](#) or AKC Canine Partners number (\$19). AKC creates titles by attaching the title to the dog's number.
- Submit fee for recording the AKC Trick Dog title (\$20) and AKC Canine Partners number (\$19) (if applicable) made payable to "American Kennel Club."

 AKC Trick Dog Performer (TKP)

Equivalent DMWYD!TM Titles

Novice Trick Dog (NTD)
 Intermediate Trick Dog (ITD)
 Advanced Trick Dog (ATD)
 Expert Trick Dog (ETD) or Trick Dog Champion (TDCH)

DMWYD - GRANDFATHERED TITLES

If you have a DMWYD title that is above Novice, (i.e. Intermediate, Advanced, Expert) you may send proof of the title (copy of DMWYD certificate) and pay only the \$20 title fee for the highest level title for which you are applying to earn the equivalent AKC Trick Dog title.

Example: If you have a DMWYD Advanced Trick Dog title, send the AKC Advanced Trick Dog Application with the \$20 title fee and AKC will issue your AKC Advanced Trick Dog title.
You do not need to apply for Novice and Intermediate Trick Dog.
