Dear AKC Trial Secretaries,

It has been brought to our attention that AKC's conformation *Show/Trial Manual* (which does not apply to agility events) contains a section which clarifies when recording fees are to be paid as they relate to dogs that are pulled from competition <u>after the closing date/time of the event</u> due to a bitch in season and/or a change in judge. In order for AKC's *Agility Trial Manual* to be consistent with the handling of these situations, we are amending the agility manual for all future events, effective immediately, as follows:

Chapter 10, Required Items for the Agility Department - Submission of Records section:

The appropriate recording fee must accompany the Report of Agility Trial form. When this recording fee is calculated, it does not include withdrawals (usually for a change of judge or a bitch in season). After acting as an event secretary for the 8th event in a calendar year a \$10 fee per event is required. Special attractions and non-regular classes are not included in calculating the recording fee. Multiple day events, or clusters, must submit an individual Report of Agility Trial form for each event date, however, a single check for the total fees is allowed.

Furthermore, if a dog has been withdrawn after the closing date/time, the entry must <u>remain</u> in the marked catalog with a designation of "Withdrawn" or "WD" followed by an explanation (e.g. bitch in season, judge change). All trial paperwork should still reflect the withdrawn dog. (examples: scribe sheet, gate sheet, running order, marked catalog, etc.) If the Trial Secretary software does not allow for marking the dog as "WD", then simply mark the dog as absent within the software, then change the paperwork by hand to reflect "WD" and the reason then initial each change.

Gate Steward's Instructions from the Judge

It is a judging requirement to brief the Gate Steward (and there may be more than one person in the course of a day or the weekend handling this position) as to how to go about their job, yet the one area that is being overlooked is how the Gate Steward is to deal with conflicts within the class and between other rings.

First, the decision as to where a dog should be moved when a conflict is realized lies solely with the judge. <u>Neither the trial</u> <u>secretary nor the trial committee has any jurisdiction in this area.</u> The Gate Steward must be informed as to how to handle conflicts "per the judge's direction" and must query the judge when anything on the gate sheet needs attention if previous guidance has not been given.

While we have no set number of dogs stated in our regulations or guidelines for the separation of two (or more) dogs handled by the same person in the same class, we have historically used a minimum of ten (10) as a common figure. Circumstances may necessitate more (or less), but again, the judge must be made aware of any movement situations and he or she will decide what works best.

Required Four Paper Copies of Club's Premium List

Four paper copies of the premium list are required to be sent to the AKC office at the same time premium lists are made available to prospective entrants. Sending AKC a PDF copy by email attachment for any reason (including online entry posting) does not negate this responsibility. Additionally, clubs **are required** to send the premium list out a minimum of two weeks prior to the opening date for entries to be accepted.

Regulations for Agility Trials, Chapter 1, Section 9 states:

At least four copies of the premium list must be sent to AKC, Attention: Companion Events and a copy must also be sent to prospective entrants a minimum of two (2) weeks prior to the opening date for acceptance of entries for the event.
