# AKC RALLY® JUNIOR SHOWCASE EVENT APPLICATION

AKC Rally® Junior Showcase trial applications and judges' panels **must** be received by the American Kennel Club at least **18-weeks prior** to the **closing date** of the trial for the club to be in compliance with Chapter 2, Sections 4 & 9 and Chapter 4, Section 1 of the *Rules Applying to Dog Shows*.

**A separate application is required for each trial.** Money penalties may be imposed or application may be rejected for noncompliance. A Disaster and Emergency Plan must be available at the event. Trial applications for Junior Showcase events must be done on paper. **Send completed application to:**
