AKC® registration applications for litters whelped by this bitch during the period of the lease must be signed by the Lessee(s). <b>Completing only the Owner Information section of this form will not automatically make you a breeder/owner of any litter(s) produced during the lease period.</b> If you are the current owner of the bitch being leased and wish to be listed as breeder/owner of any litter(s) produced during the lease period, your name must be listed in the Lessee Information section as well as the Owner Information section of the Lease Notification form.
