Each person through whose hands the dog passes, whether as owner, dealer, agent on consignment or otherwise, must complete and sign to certify that the dog transferred is the same dog identified on the application or certificate.</p> <p>A separate form must be completed and signed to record <b>each</b> transfer after the first one recorded on the back of the AKC FSS® Dog Recording Application or Certificate. Dog information must be printed exactly as shown on the front of the AKC FSS® Dog Recording Application or Certificate.
