A provisional judge may request regular status once they earn two satisfactory regular class observations, one within the year prior to the request for regular status and completed the judging of **ten (10) relevant regular class** assignments (Regular Novice, Regular Open, Regular Utility) with a minimum of **one hundred fifty (150)** total dogs judged overall. The 150-dog count may include dogs judged in the relevant and optional titling classes as listed below:

- Novice:** Regular Novice, Preferred Novice, Beginner Novice, and Graduate Novice
- Open:** Regular Open, Preferred Open, Graduate Novice, and Graduate Open
- Utility:** Regular Utility, Preferred Utility, Graduate Open, and Versatility
