it is as follows:

The Descriptive Standard of the Cocker Spaniel (English Type) Revised Feb. 1, 1945

GENERAL APPEARANCE
The English Cocker Spaniel is an attractive, active, merry sporting dog; with short body and strong limbs, standing well up at the withers. His movements are alive with energy; his gait powerful and frictionless. He is alert at all times, and the carriage of head and incessant action of his tail while at work give the impression that here is a dog that is not only bred for hunting but really enjoys it. He is well balanced, strongly built, full of quality and is capable of top speed combined with great stamina. His head imparts an individual stamp peculiar to him alone and has that brainy appearance expressive of the highest intelligence; and is in perfect proportion to his body. His muzzle is a most distinctive feature, being of correct conformation and in proportion to his skull.

CHARACTER

The character of the English Cocker is of extreme importance. His love and faithfulness to his master and household, his alertness and courage are characteristic. He is noted for his intelligence, and merry disposition; not quarrelsome; and is a responsive and willing worker both in the field and as a companion.

both in the field and as a companion.

HEAD

The skull and forehead should be well developed with no suggestion of coarseness, arched and slightly flattened on top when viewed both from the stop to the end of the skull as well as from ear to ear, and cleanly chiselled under the eyes. The proportion of the head desirable is approximately one-half for the muzzle and one-half for the skull. The muzzle should be square with a definite stop where it blends into the skull and in proportion with the width of the skull. As the English Cocker is primarily a sporting dog, the muzzle and jaws must be of sufficient strength and size to carry game; and the length of the muzzle should provide room for the development of the olfactory nerve to insure good scenting qualities, which require that the nose be wide

and well developed. Nostrils black in color except in reds, livers, parti-colors and roans of the lighter shades, where brown is permissible, but black preferred. Lips should be square, full and free from flews. Teeth should

bround be square, tun and free from flews. Teeth should be even and set squarely.

Faults: Muzzle too short or snipy. Jaw overshot or undershot. Lips snipy or pendulous. Skull too flat or too rounded, cheeky or coarse. Stop insufficient or exaggerated.

EYES

The eyes should be of medium size, full and slightly oval shaped; set squarely in skull and wide apart. Eyes must be dark brown except in livers and light particolors where hazel is permissible, but the darker the better. The general expression should be intelligent, alert, bright and merry.

Faults: Light, round or protruding eyes. Conspicuous haw.

Lobular; set low and close to the head; leather fine and extending at least to the nose, well covered with long, silky, straight or slightly wavy hair.

Faults: Set or carried too high; too wide at the top; insufficient feathering; positive curls or ringlets.

NECK

Long, clean and muscular; arched towards the head; set cleanly into sloping shoulders.

Faults: Short; thick; with dewlap or excessive throat-

Close coupled, compact and firmly knit, giving the impression of great strength without heaviness. Depth of brisket should reach to the elbow, sloping gradually upward to the loin. Ribs should spring gradually to middle of body, tapering to back ribs which should be of good depth and extend well back.

Faults: Too long and lacking depth; insufficient spring of rib; barrel rib.

SHOULDERS AND CHEST
Shoulders sloping and fine; chest deep and well developed but not too wide and round to interfere with the free action of the forelegs.

Faults: Straight or loaded shoulders.

BACK AND LOIN
Back short and strong. Length of back from withers to tail-set should approximate height from ground to withers. Height of the dog at the withers should be greater than the height at the hip-joint, providing a gradual slope between these points. Loin short and powerful, slightly arched.

Faults: Too low at withers; long, sway or roach back; flat or narrow loin; exaggerated tuck-up.

FORELEGS

FORELEGS
Straight and strong with bone nearly equal in size from elbow to heel; elbows set close to the body with free action from shoulders; pasterns short, straight, and strong.
Faults: Shoulders loose; elbows turned in or out; legs bowed or set too close or too wide apart; knees knuckled over; light bone.

FEFT

knuckled over; light bone.

FEET

Size in proportion to the legs; firm, round and catlike with thick pads and strong toes.

Faults: Too large, too small; spreading or splayed.

HINDQUARTERS

The hips should be rounded; thighs broad; well developed and muscular, giving abundance of propelling
power. Stifles strong and well bent. Hock to pad moderately short, strong and well let down.

Faults: Excessive angulation; lightness of bone; stifle
too short; hocks too long or turned in or out.

TAIL.

Set on to conform with the top-line of the back.

Set on to conform with the top-line of the back.

Merry in action.

Faults: Set too low; habitually carried too high; too
short or too long.

Various. In self colors a white shirt frill is undesirable. In parti-colors, the coloring must be broken on the body and be evenly distributed. No large portion of any one color should exist. White should be shown on the saddle. A dog of any solid color with white feet and chest is not a parti-color. In roans it is desirable that the white hair should be distributed over the body, the more evenly the better. Roans come in various colors; blue, liver, red, orange and lemon. In black and tans the coat should be black; tan spots over the eyes, tan on the sides of the muzzle, on the throat and chest, on forelegs from the knees to the toes and on the hindlegs on the inside of the legs also on the stifle and extending from the hock to the COLOR the toes.

Faults: White feet are undesirable in any specimen

COAT

On head short and fine; on body flat or slightly wavy and silky in texture. Should be of medium length with enough undercoating to give protection. The English Cocker should be well-feathered but not so profusely as to hide the true lines or interfere with his field work.

Fault: Lack of costs the west.

Faults: Lack of coat; too soft, curly or wiry. Excessive trimming to change the natural appearance and coat should be discouraged.

WEIGHT

The most desirable weights:
Males 28 lbs. to 34 lbs.
Females 26 lbs. to 32 lbs.
Proper physical conformation and balance should be considered more important than weight alone.

VOTED: That the following amendments to the Rules applying to Registration and Dog Shows be approved:

Chapter 16, Section 2, amend by rewording as follows:

"... The entry must clearly state the name, sex and color (if entered in classes divided by color) of the dog, The American Kennel Club registration number, the date of birth, THE NAME OF THE BREEDER, and the name of sire and dam..."

Chapter 18, Section 4. Amend by rewording as follows:

"... arranged as follows: Catalogue number, the name of owner, the name of the dog, The American Kennel Club Registration number, THE DATE OF BIRTH, NAME OF BREEDER, and the name of sire and dam "

Upon motion duly made and seconded, it was unanimously VOTED: That the application of Mrs. Gertrude Newhall, Woburn, Mass. for reinstatement of her handler's license, be denied.

The Executive Vice-President reported that White and Case were taking up the matter with the Commissioner of Internal Revenue in Washington to determine the exact amount due and endeavor to obtain a waiver of penalties.

A proposed emendment to the rules covering kennel names — Sections 14, 15, and 16 of Chapter 3 — was presented to the Board. The proposed change, in line with the recommendation of Hunter and Weldon, was for the purpose of requiring that kennel names be used as a prefix only and that they be issued for a five-year period with renewals and right of transfer. Discussion followed, but no action was taken. The Executive Vice-President, however, was instructed to grant kennel names only for use as a prefix until after the September meeting, when it is hoped that a formal rule will be presented to the Delegates for adoption. Labrador Retriever Standard

DESCRIPTION AND STANDARD OF POINTS
GENERAL APPEARANCE
The general appearance of the Labrador should be that of a strongly built, short-coupled, very active dog. He should be fairly wide over the loins, and strong and muscular in the hind quarters. The coat should be close, short, dense and free from feather. DETAILED DESCRIPTION HEAD

HEAD

The skull should be wide, giving brainroom; there should be a slight "stop", i.e., the brow should be slightly pronounced, so that the skull is not absolutely in a straight line with the nose. The head should be clean-cut and free from fleshy cheeks. The jaws should be long and powerful and free from snipiness; the nose should be wide and the nostrils well developed. Teeth should be strong and regular, with a level mouth

Teeth should be strong and regular, with a level mouth.

The ears should hang moderately close to the head, rather far back, should be set somewhat low and not be large and heavy. The eyes should be of a medium size, expressing great intelligence and good temper, and can be brown, yellow or black, but brown or black is preferred.

NECK AND CHEST

The neck should be medium length and powerful and not throaty. The shoulders should be long and

sloping.

The chest must be of good width and depth, the ribs well sprung and the loins wide and strong, stilles well turned, and the hind quarters well developed and of great power.

of great power.

LEGS AND FEET

The legs must be straight from the shoulder to ground, and the feet compact with toes well arched, and pads well developed; the hocks should be well bent, and the dog must neither be cowhocked nor be too wide behind; in fact, he must stand and move true all round on legs and feet. Legs should be of medium length, showing good bone and muscle, but not so short as to be out of balance with rest of body. In fact, a dog well balanced in all points is preferable to one with outstanding good qualities and defects. defects.

defects.

TAIL

The tail is a distinctive feature of the breed; it should be very thick towards the base, gradually tapering towards the tip, of medium length, should be free from any feathering, and should be clothed thickly all round with the Labrador's short, thick, dense coat, thus giving that peculiar "rounded" appearance which has been described as the "otter" tail. The tail may be carried gaily but should not curl over the back.

COAT

The coat is another very distinctive feature; it should be short, very dense and without wave, and should give a fairly hard feeling to the hand.

MOVEMENT

Movement, or action, is the crucial test of conforma-

MOVEMENT

Movement, or action, is the crucial test of conformation. The Labrador's legs should be carried straight forward while traveling, the forelegs hanging perpendicular and swinging parallel with the sides, like the pendulum of a clock. The principal propulsive power is furnished by the hindlegs, perfection of action being found in the Labrador possessing long thighs and muscular second thighs well bent at the stifles, which admit of a strong forward thrust of "snatch" of the hocks. When approaching, the forelegs should form a continuation of the straight line of the front, the feet being the same distance apart as the elbows.

When stationary, it is often difficult to determine whether a dog is slightly out at shoulder, but, directly he moves, the defect—if it exists—becomes more apparent, the forefeet having a tendency to cross or "weave". When, on the contrary, the dog is tied at the shoulder, the tendency of the feet is to move wider apart, with a sort of paddling action. When the hocks are turned in—cowhock—the stifles and feet are turned outwards, resulting in a serious loss of proplusive power. When the hocks are turned outwards, the tendency of the hindfeet is to cross, resulting in an ungainly waddle.

STANDARD OF COONHOUND (Black and Tan)

(Black and Tan)

The Black and Tan Coonhound is first and fundamentally a working dog, capable of withstanding the rigors of winter, the heat of summer, and the difficult terrain over which he is called upon to work. Judges are asked by the Club sponsoring the breed to place great emphasis upon these facts when evaluating the merits of the dog.

The general impression should be that of power, agility, and alertness. His expression should be alert, friendly, eager, and aggressive. He should immediately impress one with his ability to cover the ground with powerful rhythmic strides.

with powerful rhythmic strides.

HEAD

The head should be cleanly modelled, with medium stop occurring midway between occiput bone and nose. The head should measure from 9 to 10 inches in males and from 8 to 9 inches in females. Viewed from the profile the line of the skull is on a practically parallel plane to the foreface or muzzle. The skin should be devoid of folds or excess dewlap. The flews should be well developed with typical hound appearance. Nostrils well open and always black. Skull should tend toward oval outline. Eyes should be from hazel to dark brown in color, almost round and not deeply

set. The ears should be low set and well back. They should hang in graceful folds giving the dog a majestic appearance. In length they should extend well beyond the tip of the nose. Teeth should fit evenly with slightly scissors bite.

BODY

the tip of the nose. Teeth should fit evenly with slightly scissors bite.

BODY

Neck, Shoulders, and Chest—The neck should be muscular, sloping, medium length, extending into powerfully constructed shoulders and deep chest. The dog should possess full, round, well sprung ribs, avoiding flatsidedness.

Back and Tail—The back should be level, powerful and strong, with a visible slope from withers to rump. Tail should be strong, with base slightly below level of back line, carried free, and when in action at approximately right angle to back.

Legs and Feet—The forelegs should be straight, with elbows well let down, turning neither in nor out; pasterns strong and crect. Feet should be catlike with compact, well arched toes and thick strong pads.

Hind Quarters—Quarters should be well boned and muscled. From hip to hock long and sinewy, hock to pad short and strong. Stifles and hock well bent and not inclining either in or out. When standing on a level surface the hind feet should set back from under the body, and leg from pad to hock be at right angles to the ground when viewed both from profile and the rear. The stride of the Black and Tan Coonhound should be easy and graceful with plenty of reach in front and drive behind.

COAT AND COLOR

The coat should be short but deeper to withetend

COAT AND COLOR

The coat should be short but dense to withstand rough going. As the name implies, the color should be coal black, with rich tan markings above eyes, on sides of muzzle, chest, legs and breeching with black pencil markings on toes.

SIZE

Measured at the shoulder, Males 25 to 27 inches; Females 23 to 25 inches. Height should be in proportion to general conformation so that dog appears neither leggy nor close to the ground. Dogs oversized should not be penalized when general soundness and proportion are in favor.

Judges should penalize the following defects: Undersize, elbows out at shoulder, lack of angulation in hind quarters, splay feet, sway or roach back, flatsidedness, lack of depth in chest, yellow or light eyes, shyness and nervousness.

Faults—Dewclaws; White on chest or other parts of body is highly undesirable and if it exceeds 1½ inches in diameter should be disqualified.

The Executive Vice-President informed the Board that he had requested Mr. A.W. Brockway, of Chicago, Ill. to come in and have a talk, in accordance with the suggestion of the Board at the last meeting, that Mr. Brockway had already been in and had been told of the complaints and assured the writer that there would be no complaints in the future. He was told that he again would be approved after the first of the year.

The Executive Vice-President presented to the Board a

proposed agreement to be entered into with The National General Administration of Sports (Republic of Cuba) in the matter of recognizing the registration of dogs in Cuba, and upon motion made by Mr. Remick, seconded by Mr. Hartman, it was unanimously

VOTED: That the Executive Vice-President be and hereby is empowered to proceed with the agreement.

The Executive Vice-President reported to the Board that the Boston Terrier Club of Philadelphia had violated Section 16 of Chapter 5 and Section 1 of Chapter 9 of the rules by having published its show date and judge before approval by the American Kennel Club, and that he had communicated with the Club requesting an explanation. Upon motion duly made and seconded, it was unanimously

VOTED: That the question of imposing a fine on the Boston Terrier Club of Philadelphia be laid over.

Upon motion duly made and seconded, it was unanimously VOTED: That Section 1 of Chapter 19 of the rules be enforced on and after January 1, 1946.

The Executive Vice-President informed the Board that
Mr. Chester A. Hager, of Buffalo, N.Y. would report for duty
next week as Assistant to the Executive Vice-President.
Mr. Hartman stated that this was entirely in accordance with
the recommendations of the committee composed of Mr. Remick,
Mr. Halpin and Mr. Hartman, who had been appointed by the
Board to consider just what kind of a man would be wanted and
what his duties would be. Mr. Hartman further stated that it
was agreed another man should be found to do field work.

The Executive Vice-President informed the Board that he had invited Dr. C.C. Little to come to the meeting and outline to the Directors the work they intend to do under the grant from the Rockefeller Foundation. Dr. Little and Dr. Scott came into the meeting at noon and Dr. Little told the Directors of the work which had been authorized by the Rockefeller Foundation to be done at the Roscoe Jackson Memorial Laboratory. In general, the work would be for the purpose of obtaining scientific data regarding the inheritance of intelligence in dogs. Incidentally, the inheritance of physical traits would also be studied. Dr. Little pointed out that in many ways dogs were closer to humans in their biological characteristics than were apes and the work with dogs was intended to further the study of inheritance in humans. The method which the Laboratory intended to use with the help of the dog breeders of the country was to collect breeding data through the use of blanks furnished by the Laboratory giving breeding details such as age of sire and dam, number of puppies, their sex and number born alive and born dead and other information which would be of advantage in the work. Dr. Little further told of the actual work which would be done at the Laboratory, the farming out of brood bitches which would be bred to stud dogs kept at the laboratory, and some of the other proposed methods.

The President stated that the American Kennel Club would be very interested to help as far as it can and suggested that Dr. Little speak to the Delegates at the December meeting and give them an idea of the help which dog breeders could give

through the member clubs.

Upon motion duly made and seconded, it was unanimously

VOTED: That the salary of Henry D. Bixby, Executive Vice-President,

be and the same hereby is increased to \$9,000 per annum, retro
active to September 1, 1945.

Upon motion duly made and seconded, it was unanimously

VOTED: That the Executive Vice-President be paid as additional compensation the equivalent of two months salary, in appreciation
of his loyalty and untiring efforts.

Upon motion duly made and seconded, it was unanimously VOTED: That all employees, as of October 15, 1945, who have been in the employ of the American Kennel Club since July 1, 1943 and paid at the hourly rate, be paid additional compensation equivalent to two months' salary, in appreciation of their loyalty and untiring efforts.

The final report of Hunter & Weldon covering their work since April, in the form of a bound volume, was presented at the meeting, and it was suggested that it would be very beneficial if the Directors as they had the opportunity would read it in its entirety. Three copies were there for the members of the committee in charge of the work and one copy would be kept at the kennel club for reference. The report covers in detail procedure and the forms to be used in the work of the registration department under the changes put into effect by Hunter & Weldon. The Executive Vice-President stated that in his opinion it was probably the first time that a complete resume of methods used in the registration of dogs had ever been put on paper and it would undoubtedly be of great value as a reference in future years. The Executive Vice-

President stated that beginning October 1, complete checking is again being resumed on the registration work, but it would probably take a month or more before the complete new system was in effect all the way through.

The President read to the Board a letter from Honorable
Townsend Scudder, delegate of the American Spaniel Club, which
embodied the request from the Executive Committee of that club
that the Stud Book be again arranged in alphabetical sequence
instead of numerical sequence, a change which had been instituted in July for the purpose of speeding up both the
registrations and publishing the Stud Book. Other requests
were that complete address of the breeder be inserted in the
Stud Book records and that the Club again resume publishing
on transfers of ownership.

The President announced that the resignation of Mr. Harry I. Caesar as a Director had been accepted with regret.

The President informed the Delegates that the vacancy on the Board, Class of 1947, caused by the death of William Cary Duncan, was filled for the remainder of the year — until the

next annual meeting — by the election of Mr. John C. Neff, delegate from the Skokie Valley Kennel Club and president of the Irish Setter Club of America, and the vacancy caused by the resignation of Mr. Harry I. Caesar, Class of 1948, was filled until the next annual meeting by the election of Mr. Wm. Ross Proctor, delegate of the Del Monte Kennel Club. The Board feels it is very fortunate in getting both of these men, who are not only active in the dog game, but are already closely in touch with AKC affairs and procedure.

Mr. Neff was very instrumental in helping us with the change

Mr. Neff was very instrumental in helping us with the change in the Gazette, which has been very successful both as a magazine and financially. Mr. Proctor is known to you as a judge. We feel very happy to have them with us.

Since the last meeting here, we have engaged and he is now here with us, Mr. Chester A. Hager, who is doing field work and helping Mr. Bixby. We hope this will relieve Mr. Bixby of more arduous details.

On January 1, we are starting something which I feel has been long needed and we hope will be successful — that is, having a regular field man — Mr. Leonard Brumby, formerly president of the Professional Handlers' Association, has been appointed Field Representative.

The President reported to the Delegates that business is increasing, but the picture is not entirely clear at this time and no definite statement can be made as to whether final figures will show a profit or loss after taxes.

It is still very confusing. Through October and November, we completed a total of 56,976 registrations and transfers and received a total of 48,349, a difference of 8,627, showing that we are over 8,000 ahead of where we were.

Every effort has been made to employ more personnel and this situation has eased up. When we get new help it is of course, some time before they really are efficient. Some of our old employees have come back and we have even sent out work to be done at home.

Show applications are still coming in - we have shows even scheduled for the winter months. We are going ahead and I think a little more firmly. To December 1, we have turned out 258,000 pieces of work, compared with the previous year of 137,000. We will admit of course that this work is not as carefully done as we want it and we sometime must finish this back work and bring it up to the standard required by

the Kennel Club for its registrations.

At the close of our regular business, Dr. Clarence C. Little, director of the Roscoe Jackson Memorial Laboratory, Bar Harbor, Maine, and Dr. J.P. Scott in charge of its behavior studies, will address you and ask for your co-operation in furnishing them data for scientific studies they are undertaking as to mental inheritance in dogs.

Mr. David Wagstaff, delegate of the Chow Chow Club, asked why the Directors had taken a definite stand against double show events. The President requested the Executive Vice-President to explain to the Delegates the position taken by the Directors. Mr. Bixby pointed out that the position of the Board was not at all against double shows as such, but action had been taken against allowing clubs to continue to hold their shows in locations outside of their home territory. During the War many requirements were relaxed and among them that of allowing clubs to hold shows outside their own territory. Now that we are confronted with requests for more show dates than can be squeezed into the calendar, the Directors feel that showgiving clubs which have been formed with a definite territory in which they operate, must hold their shows in the territory originally allowed to them, and that clubs formed merely for the purpose of putting on double events which were desirable during the War due to restrictions on travelling and shipping, must make way for clubs which really serve definite territory.

Mr. George R. Lahr, delegate of the Kennel Club of Northern

New Jersey, asked Mr. Bixby why Englewood Kennel Club was required to hold its show in its own territory of Englewood, rather than on the same grounds as the Kennel Club of Northern New Jersey. Mr. Bixby explained that this requirement was in line with the action of the Board as previously explained.

Mr. John G. Anderson, delegate of National Capital Kennel Club, Inc., spoke in regard to the National Capital Kennel Club and Rock Creek Kennel Club, the latter being a club formed for the purpose of putting on a double show with National Capital, and explained that the National Capital Kennel Club voluntarily turned over some of its own territory to Rock Creek so that the latter would have a home territory of its own and thus be eligible to apply for membership in the American Kennel Club at some future date. Upon motion made by Mr. A.M. Lewis, delegate of Santa Anita Kennel Club, it was unanimously

VOTED: That the Officers, Directors and Management be thanked for the good job they have done in cleaning up the situation in the Kennel Club.

Dr. Clarence C. Little and Dr. J.P. Scott then addressed the meeting explaining the scientific work they are undertaking and the results they hope to achieve at the Bar Harbor Laboratory.

There being no further business to come before the Delegates, upon motion duly made and seconded, it was unanimously

VOTED: To adjourn.
